CONTENT LICENSE AGREEMENT

BY OPENING OR USING THE PRODUCT, EUROSYSTEMS RHINESTONE TEMPLATES AND FONTS COLLECTION, THE CD-ROM, DOCUMENTATION, MANUALS OR THE CONTENT CONTAINED THEREIN, YOU ARE CONSENTING TO BE BOUND BY AND ARE BECOMING A PARTY TO THIS AGREEMENT.

This Agreement governs the terms by which clients of Digital Art Solutions obtain the right to use clip art, templates and fonts contained in Eurosystems Rhinestone Templates and Fonts Collection.

1. Background of Agreement

(a) This is a fairly lengthy document, and it contains many important provisions that affect your rights and obligations. Upon using the Content contained in the product Eurosystems Rhinestone Templates and Fonts Collection, you accept this Agreement either for yourself or on behalf of your employer and agree to be bound by its provisions. If you are accepting on behalf of your employer, you represent and warrant that you have full legal authority to bind your employer or such other entity. If you do not have such authority or you do not accept or agree with these terms, do not accept the Agreement.

(b) In this Agreement: (i) "you" or the "Client" means you or, if you are accepting on behalf of your employer, then "you" means that employer or entity and affiliates; (ii) "Digital Art Solutions" or "we" means Digital Art Solutions, Inc.; (iii) "Content" means any Clip Art, Template or Font generated optically, electronically, digitally or by any other means or in any media or other material that you are licensing from a Digital Art Solutions Art Volume, together with any accompanying material, including any and all derivative works created from Clip Art, Templates or Fonts licensed from Digital Art Solutions ("Permitted Derivate Works"); (iv) "Clip Art" means an image or illustration that does not contain text; (v) "Template" means an image or illustration that contains text; (vi) "Font" means a typeface; (vii) "Image File" means a single electronic file that contains Content; and (viii) "Art Volume" means a single Digital Art Solutions product that contains Clip Art, Templates or Fonts on an electronic storage medium such as a CD-ROM or DVD.

2. License Terms

We hereby grant to you a perpetual, non-exclusive, non-transferable worldwide license to use the Content for the Permitted Uses (as defined below). Unless the activity or use is a Permitted Use, you cannot do it. All other rights in and to the Content, including, without limitation, all copyright and other intellectual property rights relating to the Content, are retained by Digital Art Solutions or the supplier of the Content, as the case may be.

3. Permitted License Uses:

(a) You may only use the Content for those advertising, promotional and other specified purposes which are Permitted Uses (as defined below).

(b) Seat Restrictions. Only you are permitted to use the Content, although you may transfer files containing Content or Permitted Derivative Works to your clients or printers, for the purpose of reproduction for Permitted Uses, provided that such parties shall have no further or additional rights to use the Content and cannot access or extract it from any file you provide. You may install and use the Content on only one computer at a time, although subject to the Prohibited Uses and the other terms of this Agreement, you are entitled to utilize the Permitted Uses an unlimited number of times. You may physically transfer the Content and its archives from one computer to another, in which case you may use the Content on the new computer instead. You may make one (1) copy of the Content solely for back-up purposes, and you must reproduce all proprietary notices on this single back-up copy.

(c) Permitted Uses. Subject to the restrictions described under Prohibited Uses below, the following are "Permitted Uses" of Content: Advertising and promotional projects, including printed materials, product packaging, presentations, film and video presentations, commercials, catalogues, brochures, promotional greeting cards and promotional postcards. Entertainment applications, such as books and book covers, magazines, newspapers, editorials, newsletters, and video, broadcast and theatrical presentations. The production, design, resale and distribution of imprinted or decorated products or substrates. You may use for any other purposes approved in writing by Digital Art Solutions. If there is any doubt that a proposed use is a Permitted Use, you should contact Digital Art Solutions for guidance. Any use of the Content that is not a Permitted Use shall constitute infringement of copyright.

4. License Prohibitions

(a) Prohibited Uses. You only may use the Content as expressly permitted in the preceding section 3. All other uses are expressly prohibited. For greater certainty, the following are examples of "Prohibited Uses," and **you may not:**

- display the Content on a web site or web page;
- display a photo or rendering of the Content on an imprinted or decorated product or substrate on a web site or web page;
- use any of the Content as part of a trademark, design-mark, trade-name, business name, service mark, or logo;
- resell or redistribute the Content in the form of an Image File as part of a design application, web site, clip art collection, digital image collection, whether on-line or not, including, without limitation, website templates, Flash templates, business card templates, electronic greeting card templates, and brochure design templates;
- or is otherwise made available in a manner such that a person can extract, access or reproduce the Content as an Image File;
- use any of the Content in a web-based software application or web page that enables a user to select clip art, templates or fonts and create a unique graphic by submitting text and design changes;
- use any of the Content in a web page that enables the submission of design changes or a web page that enables the selection of a template or clip art image and contains a form that enables the submission of design changes or the placement of an order; use any of the Content in a web based software application or web page that enables a user to select the Content and create a product rendering or product sample;
- use the Content for the production of heat transfers that are sold on a web site;

display the Content in a password protected area of a web site;
use the Content in a fashion that reasonably is considered by Digital Art Solutions as, or under applicable law is considered, pornographic, obscene, immoral, infringing, defamatory or libelous in nature, or that would be reasonably likely to bring any person or property reflected in the Content into disrepute;
to the extent that source code is contained within the Content, reverse engineer, decompile, or disassemble any part of such source code;
remove any notice of copyright, trade-mark or other proprietary right from any place where it is on or embedded in the Content;
sub-license, re-sell, rent, lend, assign, gift or otherwise transfer or distribute the Content or the rights granted under this Agreement without the express written permission of Digital Art Solutions;
install and use the Content in more than one location at a time or post a copy of the Content on a network server or web server for use by other users;
use, display or distribute the Content in an electronic format that enables it to be downloaded or distributed via file servers or shared in any peer-to-peer or similar file sharing arrangement;
distribute Content embedded in an electronic document such as a PDF file as a downloadable file from a web site;
place a copyright notice claiming ownership of the Content or Permitted Derivative Works created with the Content on any web site, product or product rendering;

5. Term of Agreement

(a) You can terminate this Agreement by destroying the Content and any Permitted Derivative Works, along with any copies or archives of it or accompanying materials (if applicable), and ceasing to use the Content for any purpose. The Agreement also terminates without notice from Digital Art Solutions if at any time you fail to comply with any of its terms. Upon termination, you must immediately (i) cease using the Content and for any purpose permitted under this License Agreement; (ii) if requested, confirm to Digital Art Solutions in writing that you have complied with these requirements.

(b) You only are licensed to use the Content provided you have made payment in full for the Art Volume. If you have used any of the Content without payment in full, you have violated Federal and International copyright laws. You must cease and desist use of all Content until the Art Volume is paid for in full. Continued use also is a violation of Federal and International law. To restore your license to use the Content, you must make payment in full. Digital Art Solutions will prosecute copyright violations to the full extent of the law, including but not limited to remedies available under the Digital Millennium Copyright Act.

UPON TERMINATION OF THIS LICENSE, YOU MUST CEASE ALL PERMITTED USES

(c) Digital Art Solutions reserves the right to elect at a later date to revoke or amend the license granted by this Agreement and replace the Content with an alternative for any reason. Upon notice, sent to the address or contact information provided by you, or such other address as you may advise us in writing to use, from time to time, of such replacement, the license for the replaced Content immediately terminates for any products that do not already exist, and this license automatically applies to the replacement Content. You agree not to use the replaced Content, or any Permitted Derivative Works, for future products and to take all reasonable steps to discontinue use of the replaced Content, or any Permitted Derivative Works, in products that already exist.

6. Limited Representations and Warranties

(a) THE CONTENT IS PROVIDED "AS IS" WITHOUT REPRESENTATION, WARRANTY OR CONDITION OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED REPRESENTATIONS, WARRANTIES OR CONDITIONS OF MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE. DIGITAL ART SOLUTIONS DOES NOT REPRESENT OR WARRANT THAT THE CONTENT WILL MEET YOUR REQUIREMENTS OR THAT ITS USE WILL BE UNINTERRUPTED OR ERROR FREE. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE CONTENT IS WITH YOU. SHOULD THE CONTENT PROVE DEFECTIVE, YOU (AND NOT DIGITAL ART SOLUTIONS) ASSUME THE ENTIRE RISK AND COST OF ALL NECESSARY CORRECTIONS.

(b) Certain jurisdictions do not allow the exclusion of implied warranties, so the above exclusion may not apply to you. You have specific rights under this warranty, but you may have others, which vary from jurisdiction to jurisdiction.

7. Limitation of Warranties and Liability

(a) IN NO EVENT SHALL DIGITAL ART SOLUTIONS OR ANY OF ITS AFFILIATES OR CONTENT PROVIDERS OR THEIR RESPECTIVE DIRECTORS, OFFICERS, EMPLOYEES, SHAREHOLDERS, PARTNERS OR AGENTS BE LIABLE FOR ANY INCIDENTAL, INDIRECT, PUNITIVE, EXEMPLARY, OR CONSEQUENTIAL DAMAGES WHATSOEVER (INCLUDING DAMAGES FOR LOSS OF PROFITS, INTERRUPTION, LOSS OF BUSINESS INFORMATION, OR ANY OTHER PECUNIARY LOSS) IN CONNECTION WITH ANY CLAIM, LOSS, DAMAGE, ACTION, SUIT OR OTHER PROCEEDING ARISING UNDER OR OUT OF THIS AGREEMENT, INCLUDING WITHOUT LIMITATION YOUR USE OF, RELIANCE UPON, ACCESS TO, OR EXPLOITATION OF THE CONTENT, OR ANY PART THEREOF, OR ANY RIGHTS GRANTED TO YOU HEREUNDER, EVEN IF WE HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, WHETHER THE ACTION IS BASED ON CONTRACT, TORT (INCLUDING NEGLIGENCE), INFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS OR OTHERWISE.

(b) IN ANY EVENT, THE TOTAL MAXIMUM AGGREGATE LIABILITY OF DIGITAL ART SOLUTIONS UNDER THIS AGREEMENT, THE LICENSE PROVIDED HEREUNDER, OR THE USE OR EXPLOITATION OF ANY OR ALL OF THE CONTENT IN ANY MANNER WHATSOEVER SHALL BE LIMITED TO THE FEES ACTUALLY PAID BY YOU TO DIGITAL ART SOLUTIONS UNDER THIS AGREEMENT IN RESPECT OF THE USE OF THE RELEVANT CONTENT.

(c) SOME JURISDICTIONS DO NOT ALLOW FOR THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU.

8. Indemnification

You agree to indemnify, defend and hold Digital Art Solutions, its affiliates, its Content providers and their respective directors, officers, employees, shareholders, partners and agents (collectively, the "Digital Art Solutions Parties") harmless from and against any and all claims, liability, losses, damages, costs and expenses (including reasonable legal fees on a solicitor and client basis) incurred by any Digital Art Solutions Party as a result of or in connection with any breach by you or anyone acting on your behalf of any of the terms of this Agreement.

9. General Provisions

- (a) Digital Art Solution's failure to insist upon or enforce strict performance of any provision of this Agreement shall not be construed as a waiver of any provision or right.
- (b) This Agreement is personal to you and is not assignable by you without Digital Art Solutions prior written consent and payment of reasonable assignment fee, if applicable. Digital Art Solutions may assign this Agreement without your consent to any other party so long as such party agrees to be bound by its terms.
- (c) If any court or arbitrator determines that any provision of this agreement is invalid or unenforceable, any invalidity or unenforceability will affect only that provision and will not make any other provision of this agreement invalid or unenforceable and such provision shall be modified, amended or limited only to the extent necessary to render it valid and enforceable.
- (d) You agree to pay and be responsible for any and all sales taxes, use taxes, value added taxes and duties imposed by any jurisdiction as a result of the license granted to you, or of your use of the Content, pursuant to this Agreement.
- (e) This Agreement will be governed under the laws of the State of Arizona and the federal laws of the United States of America applicable therein (without reference to conflicts of laws principles). This Agreement will not be governed by the United Nations Convention on Contracts for the International Sale of Goods, the application of which is expressly excluded. You consent to service of any required notice or process upon you by registered mail or overnight courier with proof of delivery notice, addressed to the address or contact information provided by you at the time the Content was delivered, or such other address as you may advise us in writing to use, from time to time.
- (f) Any and all disputes arising out of, under or in connection with this Agreement, including without limitation, its validity, interpretation, performance and breach, shall be finally settled under the Rules of the American Arbitration Association by a single Arbitrator appointed in accordance with such rules. The arbitration shall take place in Tempe, Arizona, and shall be conducted in the English language. You agree that violation of this agreement will cause irreparable harm to Digital Art Solutions and that no adequate remedy at law exists for such violation.
- (g) If any legal action is necessary to enforce this License, the prevailing party shall be entitled to reasonable attorney fees, costs and expenses in addition to any other relief to which it may be entitled.
- (h) This License together with all schedules or other attachments and the Limited Use License, which are incorporated herein by reference, is the sole and entire Agreement between the parties. This Agreement supersedes all prior understandings, agreements and documentation relating to such subject matter.
- (i) Nothing contained herein will be construed as creating any agency, partnership, joint venture or other form of joint enterprise between the parties.

10. Export Law Assurances.

You may not use or otherwise export or re-export the Content except as authorized by United States law and the laws of the jurisdiction in which the Content was obtained. In particular, but without limitation, the Content may not be exported or re-exported (i) into (or to a national or resident of) any U.S. embargoed country or (ii) to anyone on the U.S. Treasury Department's list of Specially Designated Nationals or the U.S. Department of Commerce's Table of Denial Orders. By using the Content, you represent and warrant that you are not located in, under control of, or a national or resident of any such country or on any such list.

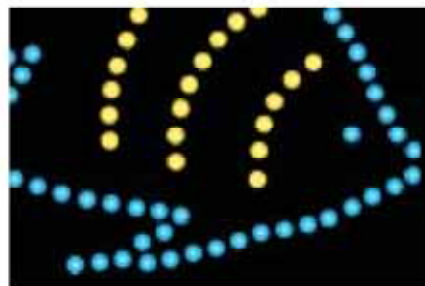
Eurosystems Rhinestone Templates and Fonts Collection includes a Windows and Macintosh compatible hybrid CD-ROM. The CD-ROM contains a collection of images which provide all of the necessary tools to create customized rhinestone graphics. The EPS and PDF files contained on the CD are compatible with most popular design, sign making or engraving programs.

PDF Rhinestone Files (PDF folder)

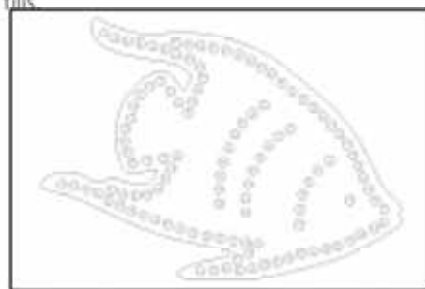
Included on this disk are PDF files designed specifically for creating rhinestone patterns. The PDF file was designed with gradient effects for a simulated stone look, ideal when creating virtual samples or proposals.

EACH PATTERN IS PROVIDED IN TWO DIFFERENT STYLES

Rhinestone Files (PDF and EPS File Formats): Rhinestone files include a rhinestone pattern composed of circles that will be used to create custom stencils and patterns. These circles can be edited and recolored to create custom variations of each pattern. The circles can also be resized to accommodate the diameter of different rhinestone sizes. Rhinestone files are provided in an EPS version with solid colors as well as a PDF version with gradient fills.



Outline Files (PDF and EPS File Formats): Outline files include both a rhinestone pattern as well as a vector outline. This format is ideal for the creation of multi-decoration designs that incorporate a combination of rhinestones and another decoration process such as cuttable heat transfers, applique or direct to garment printing. The outline portion of the file can be output independently from the rhinestone pattern. For instance, you could overlay rhinestones on top of a heat transfer created from the outlines. Outline files are provided in an EPS version with solid colors as well as a PDF version with gradient fills.



EACH PATTERN IS PROVIDED IN TWO DIFFERENT FORMATS WITH SOLID AND GRADIENT FILLS

PDF Files: The PDF versions of each file can be used to create rhinestone simulations for virtual samples or sales presentations. The PDF versions can be imported directly into CoreDRAW X3 or higher or Adobe Illustrator CS 1 or higher. In CoreDRAW, you can change the colors of the gradient fill using the Fountain Fill function. In Illustrator, you can change the gradient fill using the Gradient function. Please consult your CoreDRAW or Illustrator manuals or help files for detailed instructions for editing and applying gradient fills.

EPS Files: The EPS versions of each file can be used to create customized patterns. These are your working files, as opposed to the PDF simulation files. The EPS versions can be imported directly into most popular vector software. Consult your software manual or help files for detailed instructions for importing or editing EPS files.

Updating Smart Designer X3 or higher

The Clipart Browser in Smart Designer X3 or higher is capable of automatically detecting and displaying the images on your CD. You must run the installer program, SETUP.EXE on your CD in order to update Smart Designer so the software can recognize the CD. The installer program will also install the TrueType fonts included on the CD.

Installing Fonts

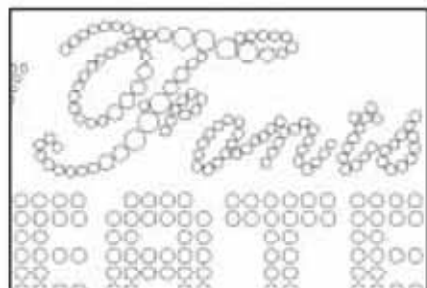
If you are running Windows, please run the file SETUP.EXE to install the fonts located on your CD. The setup program will also update Smart Designer X3 or higher enabling auto detection of the Stone Stencils CD in the Smart Designer clip art browser. You can also manually install the fonts in a Windows or Mac system. Please consult the instructions for your operating system for installing fonts.

Fonts (Fonts folder)

True Type Rhinestone Fonts: Located in the fonts folder on your CD are 7 rhinestone True Type fonts that can be used to create rhinestone patterns. These fonts are composed of circle patterns to create rhinestone patterns when text is created.

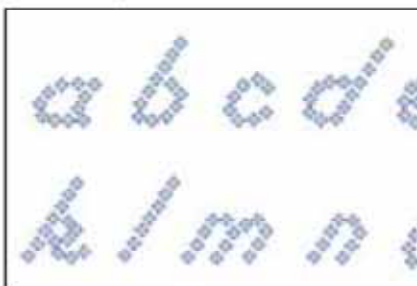
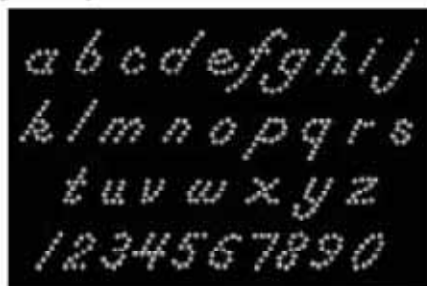


True Type Rhinestone Simulation Fonts: The set of Bling Bling fonts can be used to create rhinestone simulations by layering fonts directly on top of each other. These fonts are useful for creating a simulated rhinestone effect for digital printing or screen printing. To create a simulated rhinestone effect with the Bling Bling fonts, type your text with the Bling Bling Base font. Make two copies of the text directly on top of the original text. Change the top copy to the Bling Bling Stones font. Change the middle copy to the Bling Bling Bevel font. The composite of the three fonts directly on top of each other will create a layered rhinestone effect.



Alphabets (Alphabets folder)

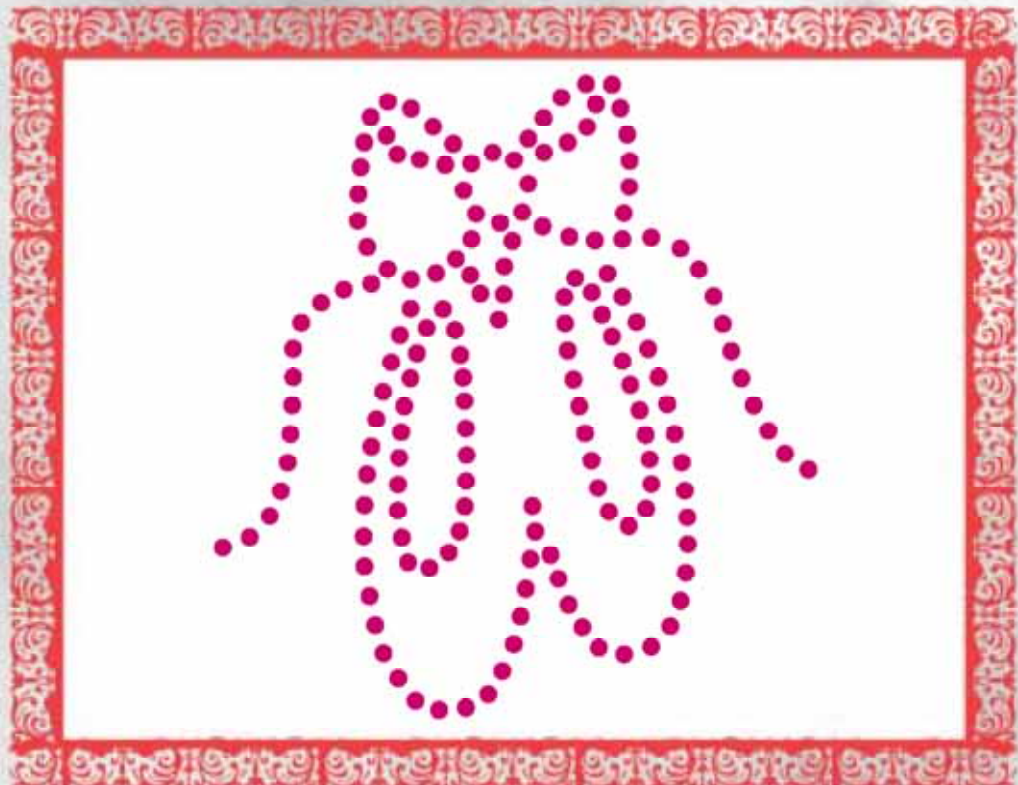
Located in the Alphabets folder on your CD are versions of each font that have been converted to EPS outline files that contain each letter in the font set. These 12 EPS alphabets can be used to create transfer sheets for producing a library of stock letters or numbers. These are not active fonts, but vector outlines.

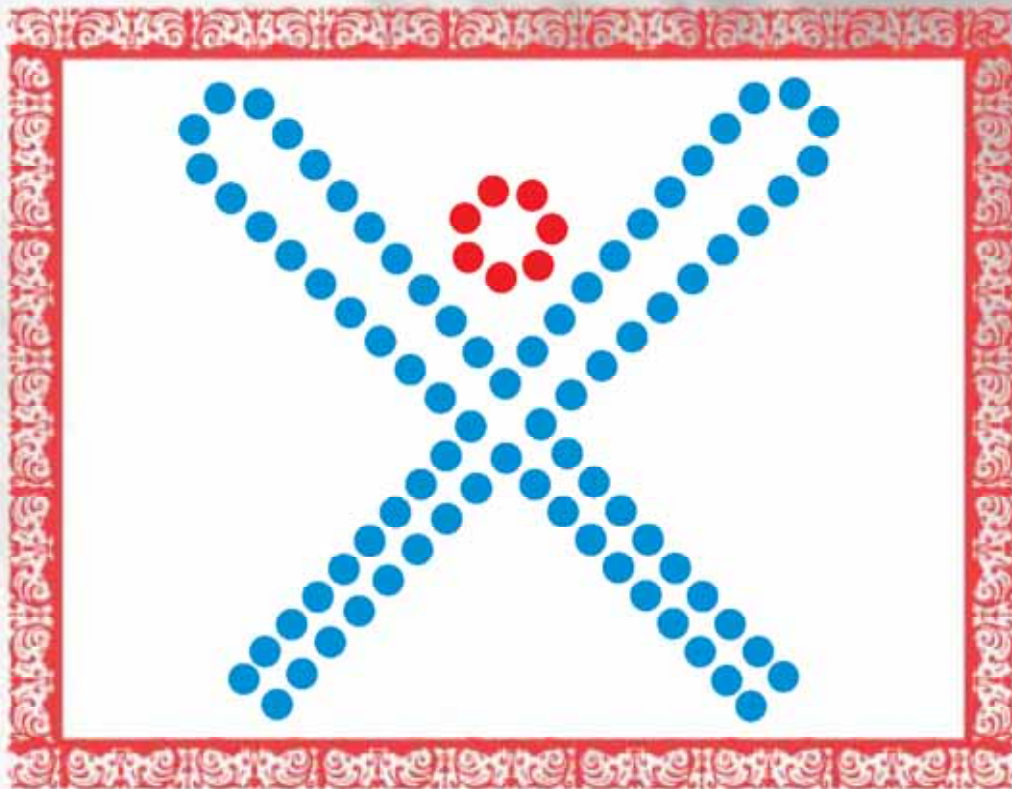

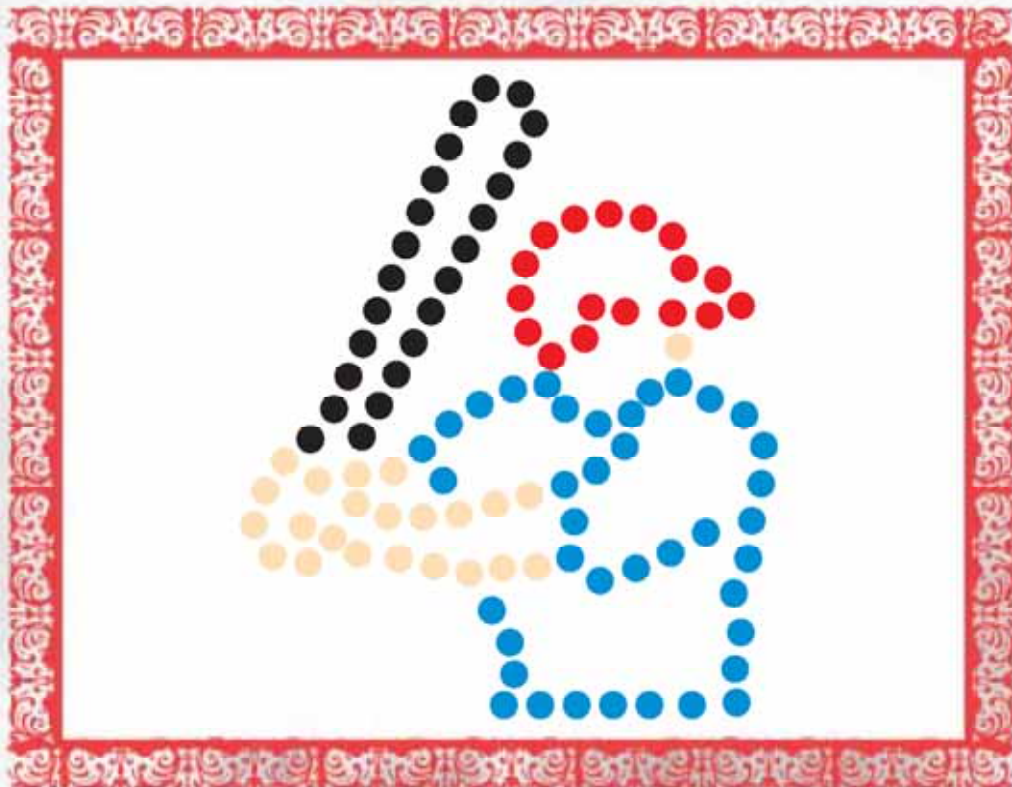


FILE NAME: BALLET SLIPPERS.EPS

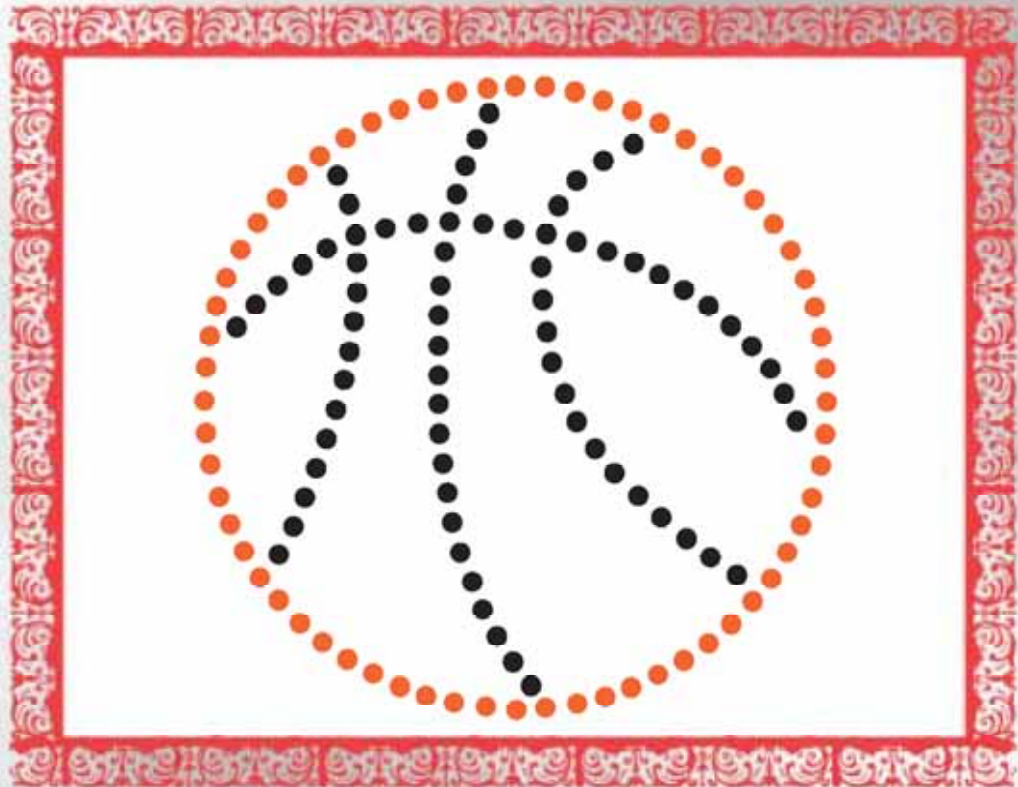


FILE NAME: BASEBALL BATS.EPS

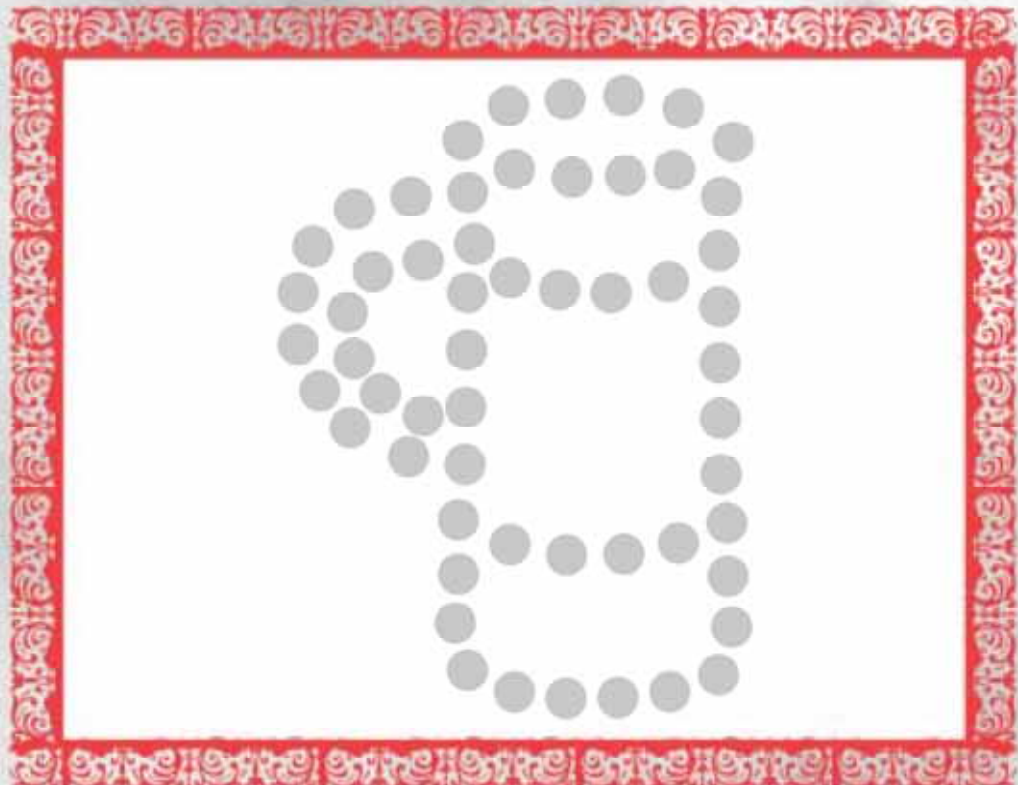


FILE NAME: BASEBALL PLAYER.EPS

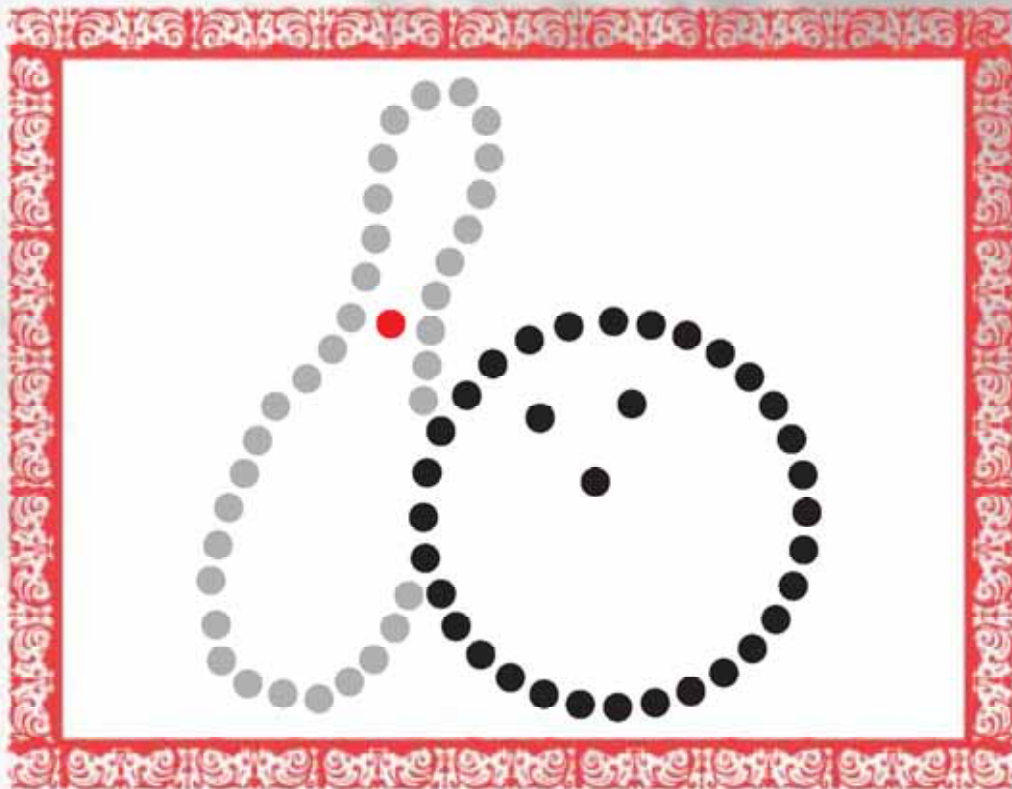


FILE NAME: BASKETBALL.EPS

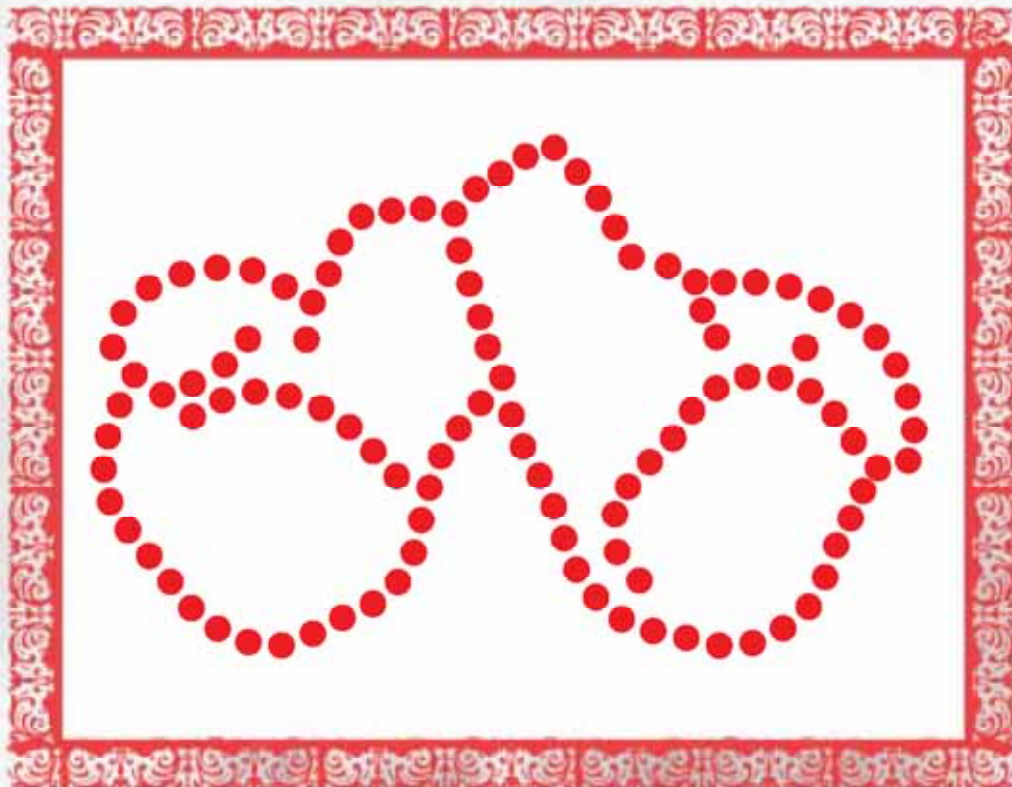


FILE NAME: BEER STEIN.EPS

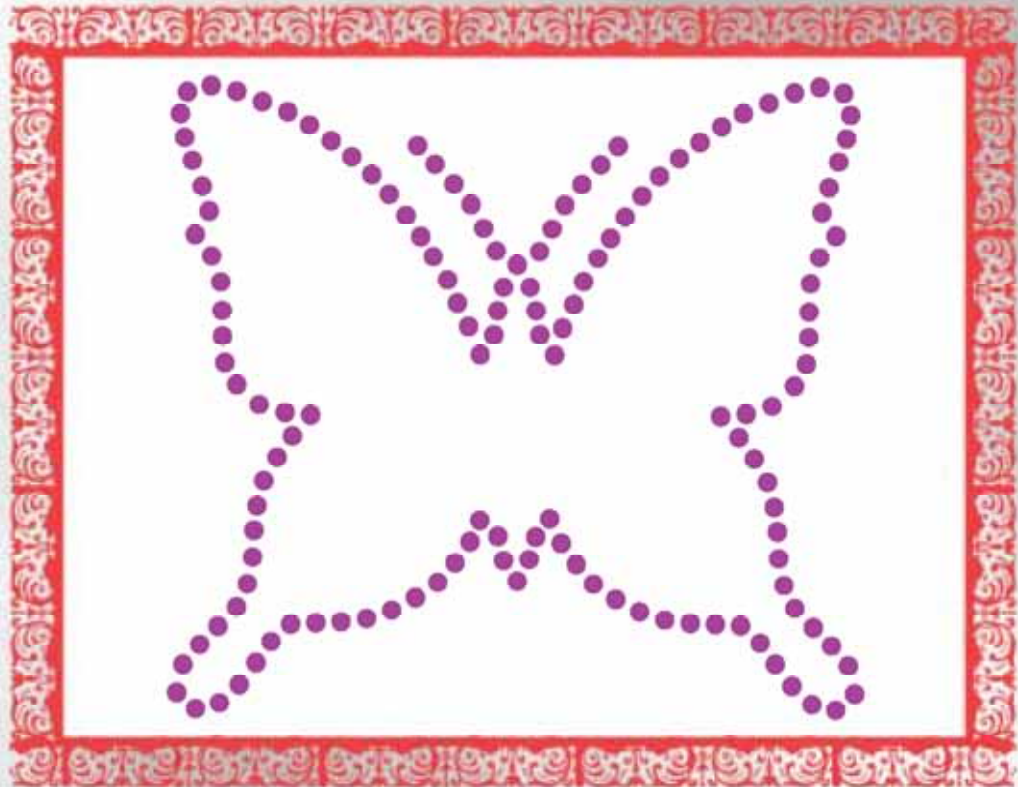

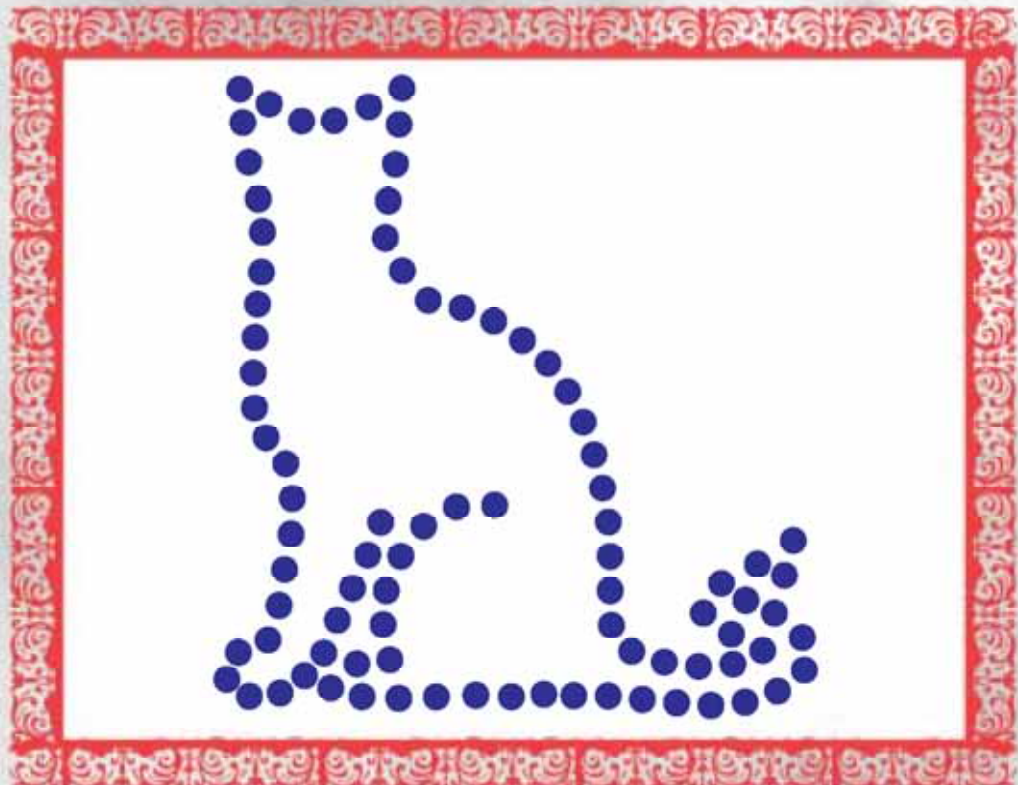


FILE NAME: BOXING GLOVES.EPS

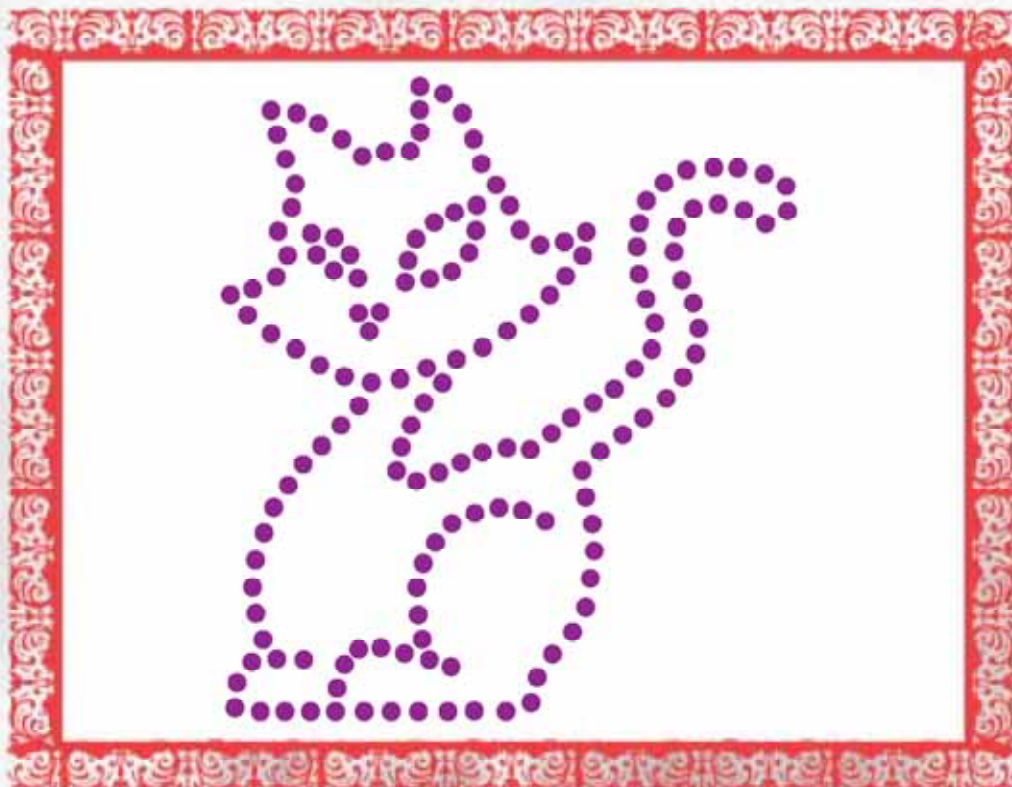

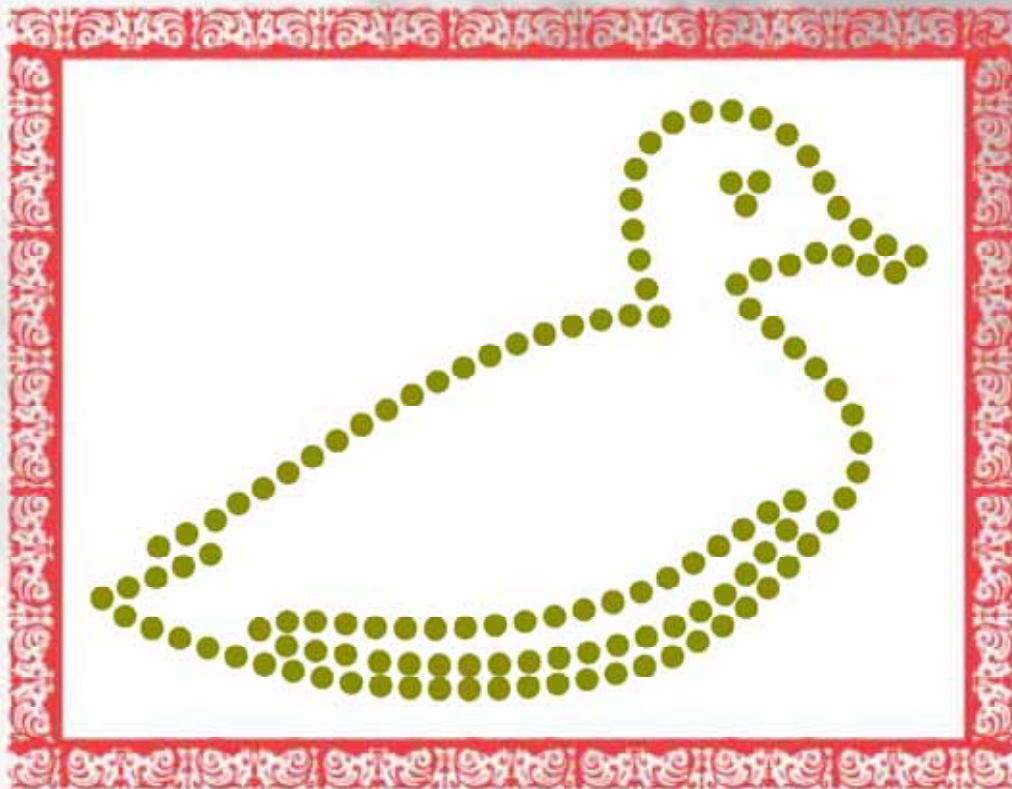

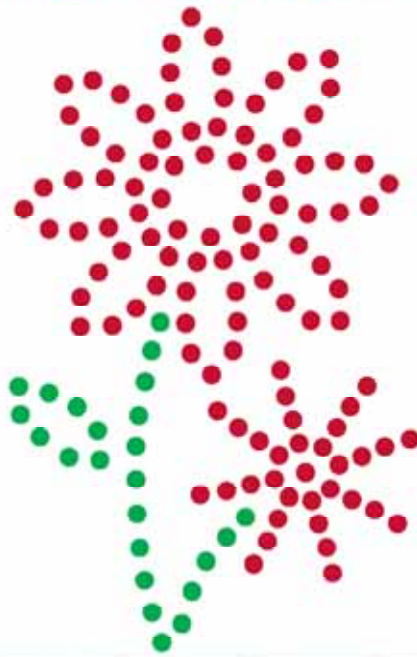

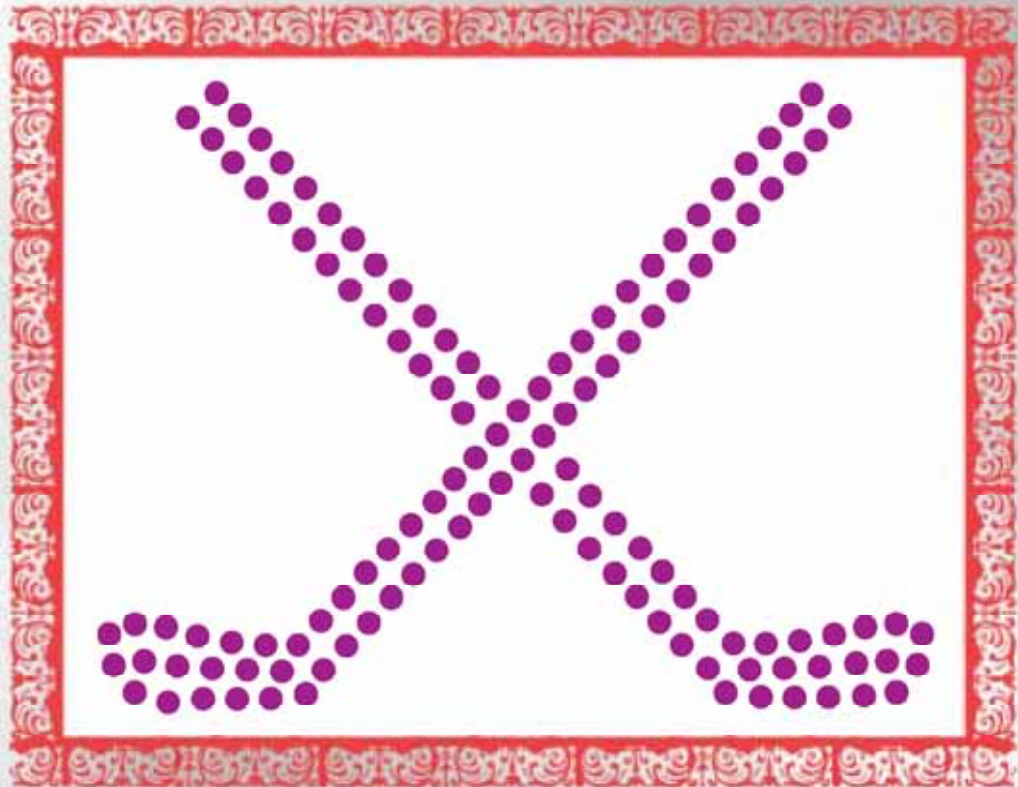


FILE NAME: HEART WITH WINGS.EPS

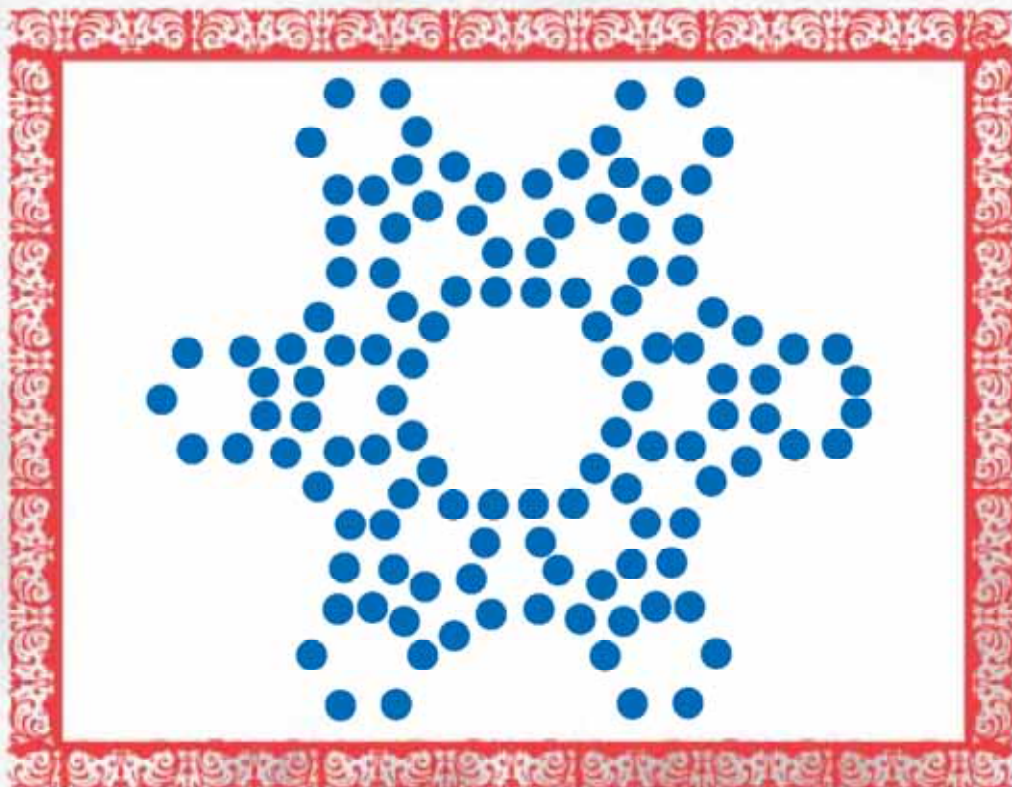

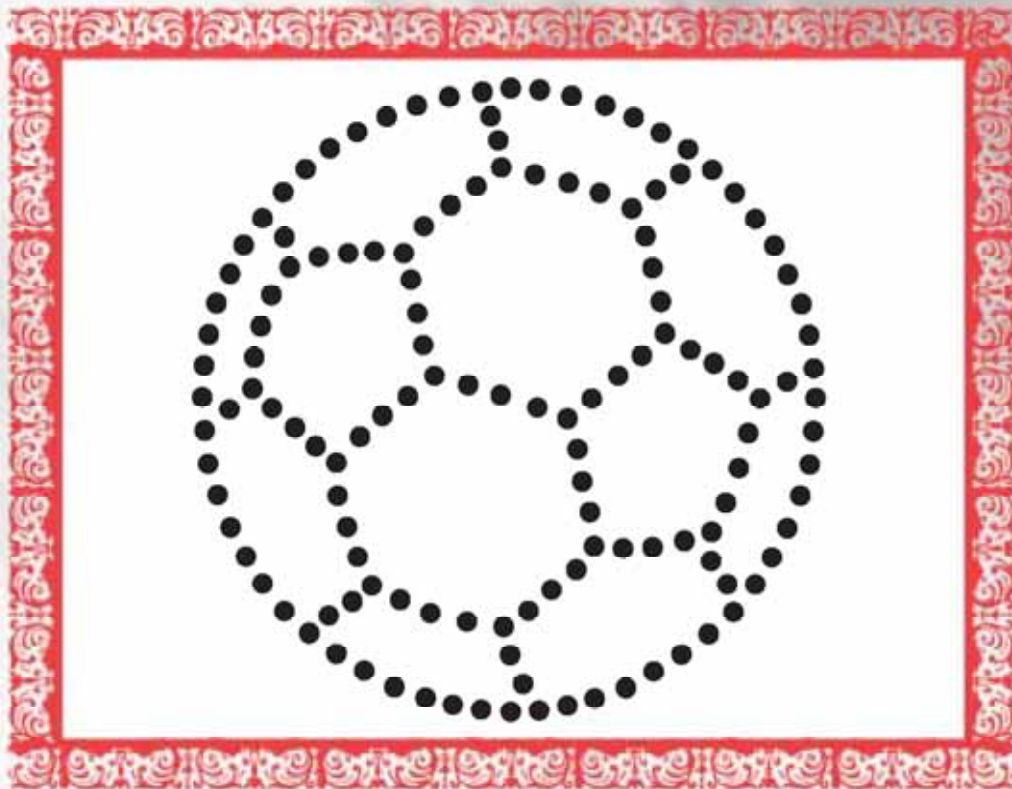


FILE NAME: SOCCER BALL FLAMES.EPS

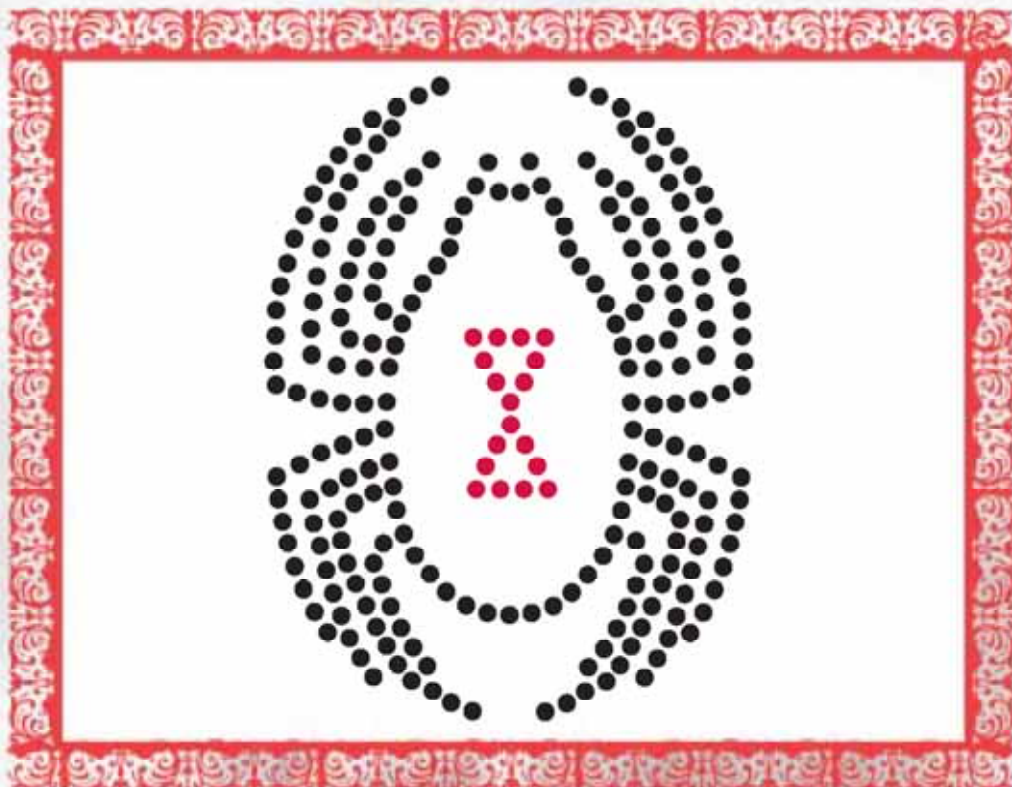


FILE NAME: SOCCER BALL SWOOSH.EPS
